ISSUE OF OPTIONS

We advise the Company has today issued 730,000 unlisted incentive options to key employees and consultants, exercisable at 37 cents and expiring 30 November 2009.

The exercise price has been struck by reference to the weighted average closing sale price of shares recorded on the Australian Stock Exchange over the 5 days immediately preceding the day on which the Board resolved to offer the options.

Vesting conditions in respect of the above options are as follows: -

- 120,000 on successful completion of the Kalplats Pre Feasibility Study,
- 10,000 on definition of a further 1 million ozs of high grade (+3 g/t) 3E PGM at the Kalplats Project;
- 145,000 on successful completion of the Kalplats Bankable Feasibility Study;
- 135,000 on successful completion of the Smokey Hills Bankable Feasibility Study;
- 165,000 on commencement of production at Kalplats; and
- 155,000 on commencement of production at Smokey Hills.
