### ISSUE OF PLATINUM AUSTRALIA LIMITED SHARES – SECONDARY TRADING NOTICE NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")

The Board of Platinum Australia Limited ("**Company**") is pleased to announce that the Company has completed an institutional placement of thirty seven million five hundred thousand fully paid ordinary shares ("**Shares**") at an issue price of \$0.81 per Share to raise approximately A\$30 million.

#### Secondary Trading Exemption

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Shares noted above will fall within the exemption in section 708A(5) of the Act.

    - ii. the rights and liabilities attaching to the Shares.*
