FAIRWAY PROJECT OPERATIONS UPDATE

Target Energy Limited ("Target") (ASX CODE: TEX) is pleased to provide the following operations update. All reported depths are measured depths below the Rotary Table (RT) on the rig floor.

BOA 12 #1 (Fairway Project, Howard County, Texas)

Report Date:	7:00 pm 21/09/11 (Western Aust Standard Time) / 6:00 am 21/09/11 (USA Central Daylight Time)
Current Depth:	1,465.5 metres RT.
Progress:	Drill ahead to 1,033.3 m. Run and cement 219.1mm (8 5/8") casing to 1,033m. Drill ahead to 1,465.5 m in 200mm (7 7/8") hole. Trip out of hole for new bit.
Hydrocarbon Indications:	Hydrocarbon shows will only be reported after wireline logs have been run and evaluated at the Total Depth of the well.
Primary and Secondary Targets:	The primary targets are the Wolfberry and Fusselman sections. The Wolfberry has the potential to recover up to 180 mBOE per well and the Fusselman up to 80 mBO.

Target Energy is earning a 60% Working Interest in the Fairway project. Drilling is expected to take two weeks to drill to the programmed Total Depth of 3,170 metres (10,400 feet).

While operations are underway, the company will issue routine releases every Thursday or at any such time that material matters require an earlier release.
