Operations update Fairway / Shepard's Channel

Target Energy Limited ("Target") (ASX CODE: TEX) is pleased to provide the following operations update.

BOA 12 #1

Potential Devonian Discovery

The BOA 12 #1 well continues to recover frac water, which is necessary prior to establishing a representative oil flow rate from the Wolfberry sections intersected. This process is normal and is expected to continue and be assessed for the next 3-4 weeks.

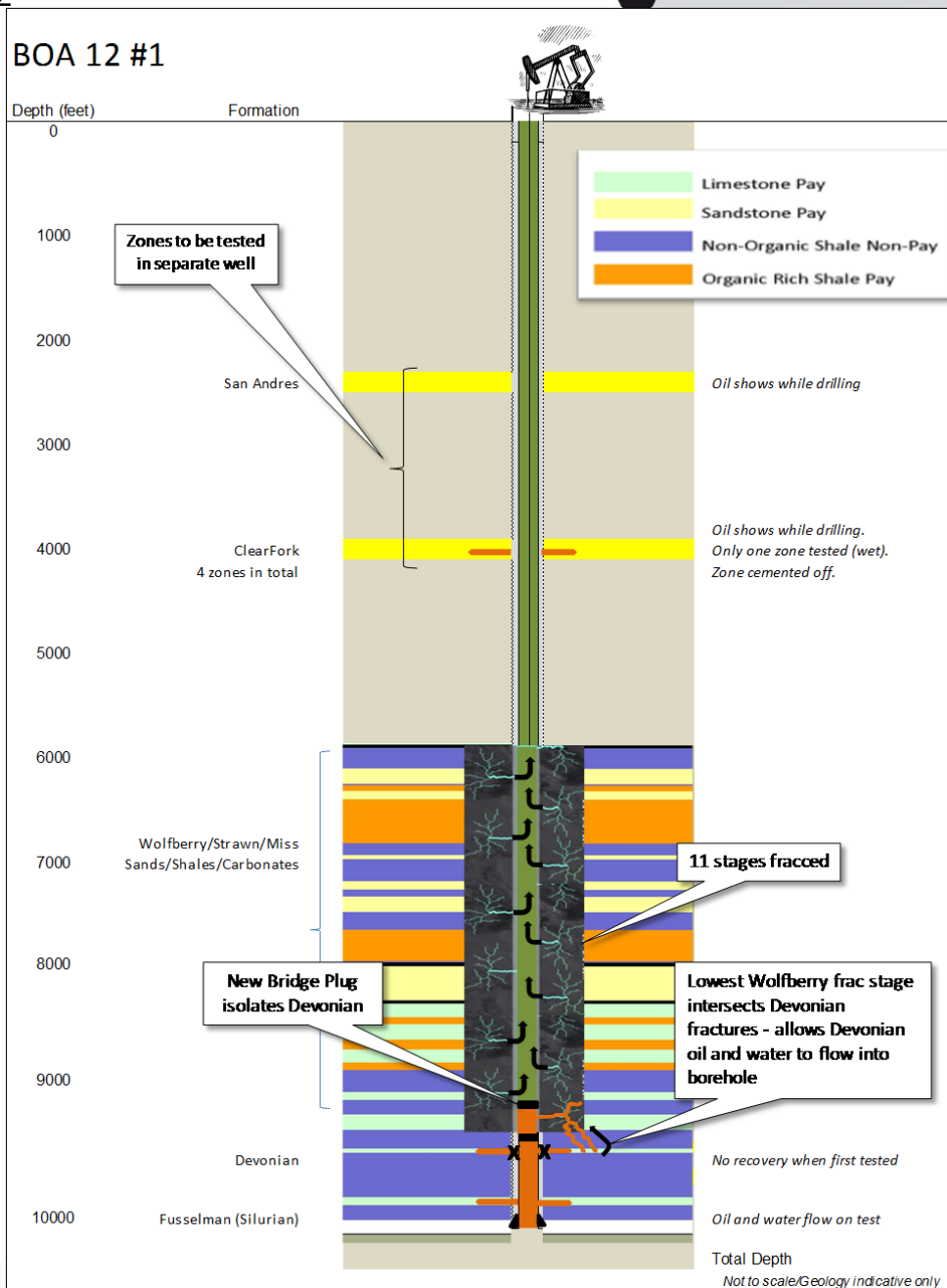


Fig 1 BOA 12 #1

Importantly, and in addition thereto, recent analysis of inflows to the well following completion of the stimulation program indicate an unexpected additional oil discovery from the deeper Devonian section (figure 1). This will, if confirmed, give the Company an important further zone of future oil production, which may subsequently be commingled with the anticipated Wolfberry production.

Target Energy is earning a 60% Working Interest in the Fairway project.

Shepard's Channel Prospect, La Fourche Parish, Louisiana

As previously advised, re-entry operations encountered gas in the borehole, with the drillpipe becoming stuck at a depth of 3,923m, approximately 21m into the channel sand.

Initial efforts to dislodge and recover the drillpipe were unsuccessful. The partners have decided to utilise a larger rig to recover the stuck pipe and drill-bit. Operations have been suspended and the current rig released.

It is expected that the replacement rig will be mobilized to the site in early March. Following the recovery of equipment, a further 95m will be drilled (to the original Total Depth of the well at 4,020m) and then a 5" liner run over the open hole. Testing will commence immediately thereafter.

Target Energy has a 10.33% Working Interest in Shepard's Channel.
