Report for the Quarter Ending 30 September 2009

Key Events

- Snapper A-3 encounters multiple zones of oil and gas pay on logs; flows gas and oil on test from Hackberry A-4 sandstone.
- Target increases interest in East Chalkley Oil Field from 25% to 35%.
- Target to earn 25% WI in 67 Bcf + 1.1 mmBC potential “Highway 71” prospect; drilling now underway.
- Target raises \$2.9 million (before issue costs) in placement and fully-underwritten rights issue.

2. Exploration

Louisiana – St Martin Parish

2.1. Snapper #A-3 (Target Energy 25% working interest)

The Snapper #A-3 well was drilled to a Total Depth of 3,198.3 metres and the rig released on 24 August 2009. Wireline logs indicated a potential 15 metres of net oil and gas pay in the Camerina, Upper and Lower 3rd Marg Tex and Hackberry Sands.

A completion rig was subsequently mobilised and the lowermost of these sands, the Hackberry A-4, perforated for production on 22 October 2009 over an 8.6 metre gross interval, from 3,105.3m to 3,113.9 m. The well was flow tested at rates up to 864 mcf/d with 5-10 BOPD, with wellhead pressures continuing to increase during the test, suggesting that stabilised rates were still to be attained.

The well will now be tied into the existing Snapper production facilities and is expected to be online within a month.

Target has a 25% Working Interest in all zones in the well.

2.2. Beyt #1 Sidetrack (Target Energy 15% working interest)

Drilling at the Beyt #1 well at the Bayou Berard prospect in 2008 encountered a major fault prior to intersecting the primary Marg Tex targets. The well was subsequently completed for production in the shallower Marg Vag sand.

The operator plans to drill out from the existing wellbore to intersect the Marg Tex sands. The 1st, 2nd and 3rd Marg Tex sands have an aggregate potential of over 750,000 barrels of oil.

The operator has now advised that drilling at the Beyt #1 sidetrack is expected to commence in the fourth quarter.

Texas – Wharton County

2.3. Highway 71 (Target Energy 25% WI)

Target has acquired a 25% working interest in the “Highway 71” gas and condensate prospect, located in Wharton County Texas, approximately 100 kilometres west-southwest of Houston.

The primary objectives are the 1st and 2nd Meek (Middle Wilcox) sands at a depth of approximately 3840 metres, with the shallower (3,300 metres depth) Upper Wilcox sand as a secondary target. The well has the potential to recover up to 52.5 Billion cubic feet (Bcf) of gas and 367,000 barrels of condensate/light oil (BC) from the Meek Sands, with the Upper Wilcox holding the potential to recover up to 15 Bcf of gas and 750,000 BC.

The New Taiton Field, five kilometres northeast of Highway 71 on the same structural trend, produced 25 Bcf and 400,000 BC from the 1st Meek sand. The South Porters Creek field, just 1.5 kilometres to the southwest has produced 4.3 Bcf and 31,500 BC since 2006 from the 1st and 2nd

Meek Sands. Seismic mapping suggests that the South Porters Creek Field may be part of the same structure as the Highway 71 prospect.

Three kilometres to the east of the prospect is the Jones Creek Field which has produced 40 Bcf gas with 1.7 million BC from the Upper Wilcox sand. The Upper Wilcox Sand is a secondary target at Highway 71, where the seismic indicates a slight structural feature.

Drilling commenced on 26 October 2009 and at the time of writing, the well was at a depth of 679m and drilling ahead.

The well is expected to take six weeks to drill to the programmed Total Depth of 4,115 metres (13,500 feet). The well is being drilled on a “turn-key” contract.

3. Development

Louisiana - Cameron Parish

3.1. East Chalkley (Target increasing to 35% working interest)

The East Chalkley project is an oil field appraisal and development program, approximately 33 kilometres southeast of the town of Lake Charles in Cameron Parish, Louisiana. The oil accumulation, on the east flank of the Chalkley Field, is a previously unidentified down-dip oil leg associated with the gas field. Target participated in the successful drilling of the Pine Pasture #2 well in 2008.

Production from the Pine Pasture #2 well is currently stable at approximately 83 BOPD with an 18% oil cut.

The drilling of a salt-water disposal well is now scheduled for November. The disposal well will substantially reduce operating costs for current and future producing wells in the field. Additional appraisal and/or development drilling will be scheduled after this program.

On October 27 2009, Target announced the acquisition of an additional 10% interest in the East Chalkley Oil Field. Effective 1 November 2009, the purchase will give Target a 35% Working Interest in the field.

5. Corporate

5.1. Capital Raising

On 18 September, 2009 the Company announced a capital raising to raise approximately \$2.9 million (before issue costs) via a placement and fully underwritten renounceable rights issue.

The placement raised approximately \$400,000 via the issue of 7.4 million shares and 7.4 million free attaching options at a price of 5.5 cents per share. The free attaching options have an exercise price of 10 cents each and will expire on 31 October 2012.

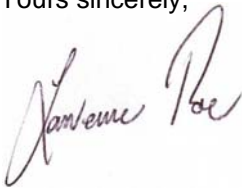
The renounceable pro rata entitlements issue to shareholders offered approximately 44,688,468 new shares and 44,688,468 new options on the basis of two new shares plus two free attaching new options for every five existing shares held as at the record date of 30 September 2009 at an issue price of 5.5 cents each to raise approximately \$2.46 million (before issue costs). The free attaching options have an exercise price of 10 cents each and will expire on 31 October 2012.

The Rights Issue, which was fully underwritten by Patersons Securities Limited, closed on 19 October 2009 with strong support from shareholders. The number of shares taken up by shareholders was approximately 33.9 million or 76% of the shares on offer. The remaining shares were taken up by the Underwriter.

The proceeds from the raising are to be principally applied to the Company's drilling and exploration activities in the United States.
